2nd INFORMATIVE NOTE: PUBLIC INFORMATION installation of "SAN AGUSTIN" PHOTOVOLTAIC SOLAR PLANT "SANTA ISABEL" in ALMOGÍA [Mojica La Gallara area], and their evacuation infrastructures in Almogía and Málaga.

The Energy Service of the JUNTA DE ANDALUCÍA has communicated by new official letter to this City Council that the previous Announcement with public information regarding the PHOTOVOLTAIC PLANT "SAN AGUSTIN" is not valid, as well as that the new announcement with public information and the Deadlines should be considered based on this 2nd announcement:

The Energy Service of JUNTA DE ANDALUCÍA has notified to this City Council that the company CONSULTORÍA DE PLANTAS FOTOVOLTAICAS, S.L. has submitted applications of PRIOR ADMINISTRATIVE AUTHORIZATION to execute the works/installations as well as the request to obtain the UNIFIED ENVIRONMENTAL AUTHORIZATION regarding AN ELECTRICAL ENERGY GENERATION INSTALLATION OF A PHOTOVOLTAIC PLANT CALLED "SAN AGUSTIN" IN ALMOGÍA [Mojica La Gallara area], WITH AN EVACUATION LINE THAT CROSSES THE T.M. OF ALMOGÍA and MÁLAGA.

This is the **PUBLIC INFORMATION process so that the interested parties/affected parties can claim** before the request of the company to obtain PRIOR ADMINISTRATIVE AUTHORIZATION to execute the works/installations of said project, as well as before the request of the company to obtain the prior and mandatory UNIFIED ENVIRONMENTAL AUTHORIZATION. To this end, has been published this ANNOUNCEMENT on the notice board of this City Council [SEE ATTACHED].

The DOCUMENTATION presented by the company can be examined either at the "Delegación Territorial en Málaga del Servicio de Energía de la JUNTA DE ANDALUCÍA", located at Avenida Juan XXIII nº 82, Málaga (requesting an appointment by calling 951 03 94 52 or by email at: energia.ma.chyfe@juntadeandalucia.es), or electronically on the website of the Transparency Portal of the Andalusian Government, at the url: <https://juntadeandalucia.es/servicios/participacion/todos-documentos.html>

In the same way as the Almogía City Council has been doing in similar situations, the interested parties can formulate how many ALLEGATIONS are deemed appropriate within the period of thirty working days counted from the day following the publication of the announcement, we understand, **at last January 9th, 2023**, in any registry of the Administration, being presented through electronic registry for those persons obliged in accordance with Law (companys).
